

## LEGAL NOTICE

The Town of Lee, Massachusetts, acting through its Board of Selectmen, invites bids for the Various Improvements to the South Lee Fire Station and Post Office in South Lee, Massachusetts. This project is funded through a grant from the Massachusetts DOER under the American Recovery and Reinvestment Act of 2009. Winning bidders will be required to comply with the 'Buy American' and reporting provisions of the Act. The bid documents include additional information to bidders concerning ARRA requirements. This bid is solicited to the General Public and a Contract will be awarded pursuant to the rules set forth in M.G.L. Chapter 149, and all related laws where applicable, of the Massachusetts General Laws.

The Project consists of: Removal of an existing exterior wall at the west side, installation of new vinyl windows, installation of new exterior finish (exterior insulation and finish system, EIFS).

The work is estimated to cost \$ 64,000

Bids are subject to M.G.L. c.149 §44A-J & to minimum wage rates as required by M.G.L. c.149 §§26 to 27H inclusive and to the Davis-Bacon Act (40 U.S.C. 276a to a-7) as supplemented by (29 CFR Subpart 5).

General Bids will be received until 2:00 P.M., Wednesday March 23, 2011 and publicly opened, forthwith.

All Bids should be delivered to: Town Administrator, Town of Lee, 32 Main Street, Lee MA 01238 and received no later than the date & time specified above.

General bids shall be accompanied by a bid deposit that is not less than five (5%) of the greatest possible bid amount (considering all alternates), and made payable to the Town of Lee. A payment Bond equal to 50% of the contract amount will be required upon award of the contract for the work.

Bid Forms and Contract Documents will be available for pick-up at 32 Main Street, Lee, MA 01238 after 10:00 a.m. February 23, 2011.

There is a plan deposit of \$50 per set (maximum of 2 sets) payable to Town of Lee.

Deposits must be a certified or cashier's check, or money order. This deposit will be refunded for up to two sets for general bidders and for one set for sub-bidders upon return of the sets in good condition within thirty days of receipt of general bids. Otherwise the deposit shall be the property of the Awarding Authority.

Additional sets may be purchased for \$50.

Bidders requesting Contract Documents to be mailed to them shall include a separate check for \$ 20 per set, payable to the Awarding Authority, to cover mail handling costs.

The building will be available for inspection on March 2, 2010 at 10:30 a.m.
