At 6:30 PM Chairman, Thomas Wickham called the Select Board Meeting to order and Chairman, Robert Lohbauer called the School Committee Meeting to Order.

The purpose of this meeting was to conduct interviews with three candidates for the seat on the School Committee vacated by Andrea Wadsworth.

The Board members reviewed letters of interest and/or resumes from Anna Westcott, Christine Lucy and Edward Lahey.

The candidates were questioned on their experience, their role as a prospective member of the committee and their willingness to run for the position which term ends May 2017. They were also questioned on their feelings about Charter Schools and on class size.

After a discussion between the members of the Select Board and the School Committee, narrowing the vote to two people, a vote was taken by a show of hands, in which Anna Wescott received three votes and Christine Lucy received four votes. *Upon a motion duly made, seconded and approved the Joint Committee members appointed Christine Lucy to the School Committee.*

At this point in the meeting, the *School Committee Chair, Robert Lohbauer adjourned the School Committee's portion of the meeting.*


