### **Table of Dimensional Requirements**

#### **NOTES:**

1. Except lot width if the street is an arc of a curve with a radius of 300 feet or less, provided that there shall be in any event not less than 80% of the required lot frontage.
2. Minimum lot size as shown in the table may be reduced by 50% if the lot is serviced by both town sewer and water and by 25% if serviced by either own sewer or water.
3. Minimum lot size shown in the table may be reduced to 20,000 square feet if the lot is serviced by both town sewer and water.
4. NR indicates that there are no fixed dimensional requirements. Any proposed use in such cases must, however, be located on a lot of adequate size for the proposed use in order to meet, in the judgement of the Planning Board, off-street parking, increased yard and all other requirements under the provisions of this chapter.
5. No residential construction shall be permitted.
6. For additional dimensional requirements pertaining to educational or religious uses see Section 9.6.
7. The total nonvegetated area shall not exceed 75% of the total square footage of the lot. Planning Board approval of a plan illustrating sufficient vegetated screening of the industrial operation from public view is required.
8. Minimum OPLI area shall be 10 acres.
9. For each lot within the OPLI District.
10. When abutting a Residential District, setback shall be 50 feet.
11. Except 45 feet or three stories where a sprinkler system is designed to the satisfaction of the Lee Fire Chief and is approved with the site plan.
12. Maximum nonvegetated area is to be 66%.
13. A landscaped buffer strip, continuous except for approved driveways, shall be established adjacent to any public road, and major trees shall be planted parallel to and at least 15 feet from the curblines as well as in a manner compatible with the buildings in the area. A coordinated landscape design for the entire project shall be reviewed by the Planning Board and incorporated into site plan review and approval.
14. A coordinated landscape design for the entire project shall be reviewed by the Planning Board and incorporated into site plan review and approval.
15. Maximum building height.

16. Maximum of building footprint.

17. The maximum percentage of the lot that can be rendered as impervious is 60%.

18. By Special Permit the Special Permit Granting Authority may allow structures to be erected that are greater than 2 ½ stories and up to 40 feet in height provided that the lot is a minimum of 1.75 acres.
