- Continued Abbreviated Notice of Resource Area Delineation Revere Solar, LLC. Zero (0) Chanter Road, 175 Silver Street, 335 Forest Street DEP #196-0452 Ms. Firstenberg of TRC presenting. A revised plan was submitted. Most of the western parcel of the land previously shown has been removed from the plan. Four wetlands and five streams were found and these are shown on the plan. An abutter who was concerned about the western portion of the plan last meeting, reviewed the new plan and was pleased with it. There is concern about the ways the streams were delineate for this plan and the tree cutting and other work to be presented in a Notice of Intent. The Scenic Mountain Act will need to be addressed at some point. A third party consultant will need to be hired and Ms. Firstenberg requested that one be appointed as soon as possible.

Motion made by Ms. Arment with second by Mr. Dalheim to have a third-party consultant review and report on this project. Unanimous approval

The Commission will discuss the logistics of hiring the peer reviewer at the end of this meeting and will be in contact with TRC.

Notice of Intent Vaclav Dvorak 230 Moose Drive DEP # pending. Construction of a single-family house and associated site improvements Mr. Puntin presenting. The Notice on Intent is

for the construction of a single-family house and associated site improvements. None of the work will be located closer than 50 feet from the bordering vegetated wetlands—these wetlands are not on the property itself. There was an Order of Conditions issued in 2005 for the road construction and the installation of utilities to this subdivision in Leisure Lee. There are bordering vegetated wetlands and an area of isolated wetlands and there are non-disturbance markers installed delineating a 25 ft. zone. The replication of the 4000 sq ft of wetlands disturbed during the road construction was completed and a Certificate of Compliance issued for the Order referred to above. However, there are deed restrictions on some of the subdivision properties in reference to wetlands that have not been resolved. DEP is requiring that these questions be resolved before a DEP number is issued. Motion made by Ms. Arment with a second by Mr. Coty to continue to the January 2, 2019 meeting. Unanimous approval
