Highway Dept.

Tyringham Rd – Bob informed the BPW that there is no update to report and we are still waiting for one easement.

Loader – Dennis Kelly explained to the BPW the repairs that are needed for the loader. After a long discussion the BPW agreed to purchase a new loader and to present it to the capital outlay committee.

Sewer Rate: Roger Scheurer explained the analysis spreadsheet that he had created for water and sewer. After discussion regarding raising the Sewer the rate the BPW agreed to raise the sewer rate from \$7.41 to \$8.14/per 100 cubic feet effective April 1, 2012 for July 1, 2012 billing.

Water Rate: Roger Scheurer explained the analysis spreadsheet that he had created for water and sewer. After discussion regarding raising the Water the rate the BPW agreed to raise the water rate from \$4.55 to \$5.00/per 100 cubic feet effective April 1, 2012 for July 1, 2012 billing.

Dave Forest moved and Roger Scheurer seconded to approve increase in sewer rate. The motion passed unanimously

Cemetery Truck – Dennis Kelly explained to the BPW that the Cemetery truck is 20 years old and needs to be replaced. After a long discussion the BPW agreed to purchase a new Cemetery truck and to present it to the capital outlay committee.
