## BOARD OF SELECTMEN MINUTES OF MEETING – May 1, 2018

Chairman, David Consolati called the meeting to order at 7:00 PM.

- 1. **Approval of Minutes:** Upon a motion duly made and seconded, the Board members voted unanimously to approve the Open Session Minutes of April 17, 2018.
- 2. **Public Hearings:** a) Global Montello Group Corp. d/b/a Convenience Plus Representatives from the Global Montello Group Corp. came before the Board to request the Select Board to approve their application to the Alcoholic Beverages Control Commission (ABCC) for a Change of Beneficial Interest and Change of Manager of Record of a §15 Wine & Malt Beverages Package Store. Upon a motion duly made and seconded the Board members voted unanimously to approve the application for a Change of Beneficial Interest and to Change the Manager of Record of a §15 Wine & Malt Beverages Package Store, of the Global Montello Group Corp., d/b/a Convenience Plus at 241 Main Street, Lee, MA, pending the final approval from the ABCC.
  - b) Danielle L. Dragonetti, d/b/a D Spoon, LLC came before the Board to request the Select Board to approve her application to the ABCC for a new All Alcohol License at 5 Railroad Street, Lee, MA (the former Pho Saigon Restaurant). After a brief discussion regarding the whether or not Ms. Dragonetti was TIPS certified and had a ServSafe Certification the Board Members voted unanimously to grant an All Alcohol License to Danielle L. Dragonetti, d/b/a D Spoon, LLC., at 5 Railroad Street, Lee, MA, pending the final approval from the ABCC and the receipt from M. Dragonetti of her TIPS certification and her ServSafe Certification.

  - <u>Mass DOT Project Development Lenox, Lee, Stockbridge Resurfacing and Related Work on Route 7 The Board members were notified with a letter from Mass DOT concerning the Project which states that the MassDOT is proposing to resurface Route 7 in the town of Lenox, Lee and Stockbridge.
