BOARD OF SELECTMEN MINUTES OF MEETING – April 20, 2021

Chairman David Consolati called the meeting to order at 7:00 PM, stating that pursuant to the Open Meeting Law, this is an audio recording with a roll call vote of members present by ZOOM.

1. **Approval of Minutes**: Upon a motion duly made and seconded and upon a roll call vote, the Board members voted unanimously to approve the open session minutes of April 6, 2021.

2. **Public Hearings**: Special Permit Hearing - Application from Ann Doyle Deely, to grant a Special Permit to allow for the conversion of property at 218 Main Street, Lee, from the existing use of three apartments and an office to a five-apartment residential building with no office space. The structure is proposed to be substantially unaltered with the existing utilities utilized. The existing parking, paved area to be substantially the same. All will be in the existing footprint of the building under Chapter 199- Special Permit 13.4 and Multiple Dwelling Developments 9.2 – Site Plan Review. The building is located at 218 Main Street, in the DCBC Zoning District, designated as Map 12A, Lot 163.

Contractor Thomas Wickham, came before the Board representing Ann Doyle Deely's request for a Special Permit. At this point in the meeting, Chairman Consolati recused himself as he works with Tom Wickham. Sean Regnier read into the record, the recommendations of the Planning Board, as follows: 1) The applicant will submit a parking plan showing sufficient parking and 2) the location and plans for an enclosure of the dumpster.

After brief discussion wherein the Board discussed the parking lot and marking off the spaces with lines and enclosing the dumpster, Patty remarked that this is a great use of the space and it will

essentially look the same, while also meeting the needs of more housing. Tom added that other than those two changes there is no outside work to be done. Patty made a motion to waive the strict Site Plan Requirements as there is no outside work to be done, Sean seconded the motion and all were in favor.

Upon a motion duly made by Patty to waive the strict Site Plan Requirements as there is no outside work to be done, Sean seconded the motion and upon a roll call vote, the Board members voted unanimously to approve the Special Permit for 218 Main Street, Lee, MA (Ann Doyle Deely) and voted unanimously and upon a roll call vote

Upon another motion made and upon a roll call vote, the Board members voted unanimously to grant the Special Permit by the Special Permit Granting Authority upon the following motions and findings that the proposed use:

- 1. Is in compliance with all provisions and requirements of this chapter and in harmony with its general intent and purposes; because the plans submitted shows it to be so.
- 2. Is essential or desirable to the public convenience or welfare at the proposed location; because it fills the need for housing.
- 3. Will not be detrimental to adjacent uses or to the established or future character of the neighborhood; because it is already an existing rental building and the property's use won't be changed as it is being used for much of the same purposes as already established and will not change the nature of the residential community.
- 4. Will not create undue traffic congestion or duly impair pedestrian safety; because there will be no substantial increase, the conversion won't create additional congestion as there is a parking area with the required number of parking spaces.
- 5. Will not overload any public water, drainage or sewer system or any other municipal facility to such an extent that the proposed use or any existing use in the immediate area or in any other area of the town will be unduly subjected to the hazards affecting public health, safety or general welfare; because there will be no substantial increase in those uses.

- 3. **General Business**: a) Town of Lee Proclamation Oldest Resident of the Town of Lee The town was notified by The Landing at Laurel Lake that one of their residents, Barbara F. - b) <u>Gail Ceresia Article for bylaw 172 Amendment</u> Gail Ceresia came before the Board with a Citizen's Petition, along with the required signatures that she would like on the ballot for the upcoming election for the Town Representatives to vote on. In Chapter 172, she would like the word "hazard waste" added to this. *Upon a motion duly made and seconded, and upon a roll call vote, the Board members voted unanimously to add this language to the Warrant for the upcoming election.*

Patty suggested that if they are unable to park in the Park, they could possibly park in the old Price Chopper parking lot. Patty said she would ask Cindy to follow-up. *Upon a motion duly made and seconded and by roll call vote, the Board members voted unanimously to allow the Berkshire Health Systems bloodmobile to set up either in the Park or at the Price Chopper Parking lot*.

- e. <u>Veteran's Memorial Discussion</u> Patty Carlino stated that she wanted to update on the Veteran's Memorial discussion from last meeting. She is still trying to get more information regarding a memorial and will continue searching.
- f. <u>Lee Youth Commission Update</u> Kathy Hall came before the Board stating that she had given a copy of her business plan and demographic profile to the Board. The business plan is a draft, but very thorough. If this project were to come to fruition, she would need town backing and would have to look for donors. Regarding construction she is working with a consultant (free of charge) and with Matt Puntin. Brian Hallet's consultation regarding a conceptual idea of the building, business plan and demographic profile is part of the feasibility of the building.

Her update on the playgrounds is: <u>South Lee Playground</u> - the slides have been fixed. New equipment is being considered to replace the swings that were destroyed in the storm. <u>Bradley Street Playground</u> - they are measuring for new fixtures for the little kids. <u>Athletic Field</u> - Cleanup by 11th grade students/tables sanded, leaves raked by the fence. The tables were going to be painted but the weather did not allow for the painting. David Consolati made a comment that right now supplies are in high demand and are difficult to get materials, therefore, people are paying a premium. Is this something that we should be doing right now?

- g. Memorial Day Parade/Discussion Jim Wilusz at the Health Dept., per the Governor's orders states that there will not be a parade this year and in fairness to the organizers Patty suggested we call it off again. Patty added that we could do the same as last year and have a small Veteran's ceremony in the park and CTSB could film it. Chairman Consolati agreed that he can't see how we could do a parade this year. Patty stated that she would follow through with this same as last year.
- h. <u>Berkshire Gas Permit</u> Upon a motion duly made and seconded and upon a roll call vote, the Board members voted unanimously to grant a permit to Berkshire Gas Company for a Class II Leak Repair at 130 Orchard Street.

Hold Meeting on the Football Field on June 24, 2021 according to the following plan/options:

*B – Provide RENTAL chairs for Reps – All others bring your own chair
