Notice of Intent: William and Becky Brunell 35 Run Way Map 30 Lot 69 DEP \#1960484 Installing a metal storage building in a riverfront area Mr. Kulig of Berkshire Engineering presented the plan with Mr. Brunell contributing. It is considered a redevelopment project as the parcel of land is already fully developed. A $54^{\prime} \times 80^{\prime}$ p, 4420 SF storage shed will be placed in an already disturbed area. Riverfront restoration and stormwater management improvements are proposed. These will include removal of invasive plant species, planting native, non-invasive shrub species and seed mix, a fabric grass lined swale to receiver runoff from paved areas and a split rail fence or other barrier to limit access and delineate an area to be restored. Existing vegetated areas will remain. The Commission has requested that the revised plan that addresses the DEP comments be submitted to DEP for approval. Motion by Mr. Philpott with a second by Mr. Coty to approve the Notice of Intent DEP \#196-0484 to install a metal storage building in a riverfront area and pending the approval of the revised plan by Mark Stinson of DEP.

Notice of Intent: VS Cape Smart, Inc. 1435 Cape Street Map 21 Lot 25 Installing a 3.5acre solar installation Mr. Siter and Mr. Mack presented the plan. The proposed work consists of re-grading the existing gravel pit and installing a 3.5 -acre solar installation. The existing 12' wide gravel driveway and bridge will be used to access the site. The connections for the utilities will come off Cape Street and utility poles will be installed in the 50' boundary of a

BVW. There will be an improvement to the stormwater structure; a level spreader will be installed. A retention pond will be placed to help with the runoff. There will be no disturbance to the stream in the back of the property or the beaver pond. There were questions about the stabilization of the bank by the solar panels. Once the installation is done pollinator seed mix will be planted under and around the panels. There will also be rehabilitation done around the road area. Mr. Latino asked questions concerning the run-off and site line.
