7:00: David Iselin 315 Church St. re: Request for Determination of Applicability for an addition to his house. Mr. Iselin explained that the project has changed since this application was submitted. He now plans to build a 6' x 6' foyer to his house. The approximate distance from the addition to the pond is 90'. He plans to use two techno posts for the front of the addition and the back of the addition will be tied into the house. Ms. Arment made a motion to continue the public hearing to give Mr. Iselin time to get the revisions to the application to the Commission, seconded by Mr. Philpott, vote unanimous. The Hearing was continued to 4/2/14 at 7:45 PM.

230 Church St. re: tree cutting on the site. The Commission received an anonymous call regarding tree cutting. The concern is that there is a perennial stream crossing the property and this cutting maybe within our jurisdiction. Ms. Garry looked up the owner of the site and it appears to be Rita Chittenden. Ms. Garry will send her a letter asking her to appear before the Commission at our next meeting and for her response to our letter within 7 days from date of letter.

Ms. Arment made a motion to accept, as written, the minutes of 3/15/14, seconded by Mr. Philpott, vote unanimous.

Ms. Arment mentioned that she will not be at our next meeting and she asked Mr. Dalheim to chair the meeting. Mr. Philpott will handle the budget discussion with Mr. Nason.

Mr. Dalheim mentioned that he contacted Mr. Mark Alimansky, Laurel Lake Preservation Association, about Zequanox which is for use on zebra mussels. Mr. Alimansky said he was aware of the product and EPA is testing it in western lakes.

Mr. Philpott mentioned that the refill of Goose Pond started on 3/1/14 and they are hoping that the lake will be filled by 4/15/14.

Ms. Hansen asked if the Commission has been contacted by Boyd Converting because she has heard that they plan to install a solar array on their property. Ms. Garry said that nothing has been received.

Ms. Arment motioned to close the meeting at 8:00 PM, seconded by Mr. Dalheim, vote unanimous.
