- 3. <u>Hydration Station:</u> The Appalachian Trail Community Committee provided and operated a hydration station for hikers at the Main Road crossing in Tyringham during extremely dry, hot weather in the summer of 2022. The hydration station provided soda and fruit, as well as water, and it was of great benefit to hikers. Water supply was also be provided and monitored at other AT road crossings where water supply was needed. # Massachusetts Walking Tour, June 17-26, 2022, Appalachian Trail – Massachusetts

The Massachusetts Walking Tour is a not for profit organization from Central Massachusetts that annually hikes and performs in concerts within the state of Massachusetts for 10 consecutive days to generate awareness of the trails within the communities and the state. In June of 2022 the Massachusetts Walking Tour chose the ninety mile section of the Appalachian Trail in Massachusetts for their hike and made 10 separate town performances. The tour was assisted by towns and communities along the Appalachian Trail as well as volunteers from the Appalachian Mountain Club and the ATC Community Committees of Dalton and Cheshire.

The Town of Lee ATC Community Committee assisted the Massachusetts Walking Tour prior to and during their performances in both the towns of Tyringham and Lee, Massachusetts. In late spring the Lee ATC Committee met with a walking tour co- founder, Raianne Richards, and assisted in the distribution of posters and fliers throughout central Berkshire County.

During the Massachusetts Walking Tour event, the Lee ATC Community Committee assisted the tour's members with transportation for themselves and their backpacks and instruments and as well as slack packing the group while they hiked through difficult elevation sections of the Appalachian Trail.

The ATC Community Committee of Lee attended the concerts in the town of Tyringham on Monday, June 20, as well as, the Lee Library Concert on Tuesday, June 21, at 6:00 pm. The committee subsequently assisted in transporting the tour group to their overnight accommodations in the next town as well as transporting their gear and instruments.

Close ties and bonds have developed throughout Berkshire County towns and communities with The Massachusetts Walking Tour members as a result of their dedication to perform and hike the Appalachian Trail for 10 very difficult days. # Lee Middle and High School Appalachian Trail Education Program 2023 and ongoing...

The AT Community Committee is working in conjunction with the Massachusetts AT Management Committee/AMC and the school AT Community Committee member and Teacher/Faculty Liaison, Nicole Clarke, to provide educational programs and trail experiences for students that attend Lee Middle and High School.

An AT Trail Event is being created for students to attend this coming May. It will include a hike along the AT and a simple management project. The AT Trail Event is the final leg of the Educational Program which began on December 8, 2022 with 2 Appalachian Trail Informational Assemblies that were presented to both Lee Middle and Lee High School by the Massachusetts AT Management Committee. The assemblies were then followed up with presentations on January 20, 2023, LMHS Intercession Day, that provided two 1 hour demonstrations of hiking gear and discussion on trial safety. Both the December 8, 2022 assemblies and Intercession day demonstrations held on January 20, 2023 were well attended by students.

It is the intention of the Appalachian Trail Community Committee to continue to provide AT Education Programs within the Lee School system, ongoing. The more our committee and the AT Management Committee/AMC becomes involved with the students, the more we will understand the students' interests about the trail and encourage those interests in future educational programs Volunteer Liaison: Nicole Webster:

# Massachusetts Department of Conservation and Recreation

The Massachusetts Department of Conservation and Recreation is the state agency that manages publicly held state land for the Commonwealth of Massachusetts. DCR manages and maintains the two state parks that are partially located within Lee Massachusetts, October Mountain State Forest and Bear Town State Forest. The Appalachian Trail passes through both of these state parks, and the Massachusetts AT Management Committee/AMC works alongside the DCR to maintain these sections of trail. # Lee Greener Gateway Committee

The Recycling/Greener Gateway Committee is a town committee whose mission is to be instrumental in Lee's becoming a Greener Gateway to the Berkshires – more environmentally-friendly, sustainable, and attractive for residents, visitors, and future generations. Two examples of projects are the following:

- Reducing the use of plastics: We were the driving force behind the bylaws passed at the 2016 Town Meeting regulating the use of thin-film plastic shopping bags and polystyrene drink and food containers.
- During the Committees 6<sup>th</sup> annual roadside clean up, April 30, 2022, the committee and group of volunteers removed 70 bags of trash, 47 bags of recyclables, an unbelievable 965 nip bottles, tires and even golf clubs. The event ended with volunteers receiving a thank-you bag.
- Achieving zero-waste: Since 2013, we have worked closely with the Lee Chamber of Commerce and others to achieve zero-waste during Founders Weekend, getting closer to our goal each year. www.lee.ma.us

# Massachusetts Department of Transportation

The Lee DPW works directly with the MASS DOT in maintaining road infrastructure projects within the town of Lee and maintains the plowing of public sidewalks along state roads within the town.

# 10) What cultural and/or historical information is available about your community?

#### Lee's Incorporation

The first settlement in the area, now known as Lee, was originally called Dodgetown as early as 1760. Dodgetown was named after its founding settler, Asahel Dodge, who immigrated to the area from Cape Cod. Lee was incorporated in 1777 from lands of Great Barrington and Washington. It is estimated that the population at the time of incorporation was around 200. The Town was named after Revolutionary War General Charles Lee.

As a result of the of the Revolutionary War, the pursuit of an ordinary life on Cape Cod became difficult due to the loss of men, money, and the breaking up of the fishing industry. Due to loss of livelihood, people began migrating west. Rumors of the rich fertile lands on the Housatonic River spread that resulted with in gradual influx of settlers from the east cost of Massachusetts. As the old story goes, when east coast settler James Goodspeed arrived in Lee in 1780 and came in sight of the house where his Uncle Hamblin lived, he asked, "Whose hog-pen is that with a chimney to it? ", "be quiet," was the reply; "That is where your uncle lives." Most homes at that time were small log houses located on the side of mountains. Marked trees glazed roadways and a tree felled across a river served as a bridge. Sounds a lot like the AT?

At the time of Lee's incorporation in 1777 there remained a small number of Mohican Native Americans that resided in the Stockbridge, Massachusetts Township that borders with Lee. Prior to that time, the Mohican had lived sparsely in the territory and were mostly known as the Stockbridge or Housatonic Tribe. The Mohican claims to land were recognized by the settlers and they were compensated at the time of land sales with money, cider and/or rum. There was no village of Native Americans in Lee, but Mohican Native Americans were known to camp in Lee along the Housatonic River, for 4-6 weeks in the early spring to make maple sugar from the syrup running trees. Over time, the dwindling Mohican population took on the ways of settlers' dress and lifestyle and many migrated further west to the Oneida Reservation in New York or further onto Wisconsin or Missouri.

#### Lee's Heritage

Lee has a strong heritage of being a paper mill town. In 1867, with 25 paper mills, Lee was the leading manufacturer of paper in the United States. Lee is also well known for its marble quarry that produced and provided marble for the building of many historical buildings and monuments throughout the United States including St. Patrick's Cathedral and Grant's tomb in New York City, and The Lincoln Memorial and Washington Monument in DC.

The beginning of the 21st century saw a decline in the paper industry in Lee as the paper industry relocated to other regions of the United States, as well as overseas. As of 2000, there remained 5 paper mills in Lee. Today, one mill, the Willow Mill that produces specialty papers, remains in operation in South Lee. Both Marble and Lime continue to be mined in Lee today.

The town of Lee continues to have manufacturing companies along the Housatonic River and has become a popular location for upstart corporations such as the growing medical supply industry. Lee has also become a popular location in the development of the cannabis agriculture industry.

Because of its close location to New York City and Boston, Berkshire County has always been a vacation destination and cultural mecca. Over the past 20 years, Lee has capitalized on this and has emerged into a popular destination for vacations, shopping, entertainment and fine dining.

Lee, Massachusetts welcomes tourists and residents alike to enjoy its many ongoing festivals, fine restaurants, hiking trails, Golf Course, Inns, Bed and Breakfasts, shops and many events throughout the year. We welcome residents and tourists alike to gather on a park bench on the town green in the center of town. The property of the First Congregational Church of Lee, the green is the focal point of the weekly Saturday Farmers Market, Sunday Concerts in the Park, Art festivals, Jazz weekends and Friday Night family movies under the summer skies. Not to mention, the Lee Chamber of Commerce information booth on the green where its volunteers provide diverse information and brochures for activities throughout the Berkshires.

Outdoor activities in Lee include hiking and camping in October Mountain State Forest and Beartown State Forest, hiking the Appalachian Trail or just walking around town to scope out the fine eateries, library and shops. There are also many shorter footpaths in town maintained by the town's non-profit, Lee Land Trust. Whether visitors just want to put their feet up or go for a swim there is always Lee's town beach, Sandy Beach, for a change of pace.

The Town of Lee's main event is the Annual Lee Founders Day Weekend which takes place in September. The weekend begins with outdoor food vending and Fireworks on Friday night and continues throughout the weekend with the Saturday parade, food and dining, craft exhibits and many open markets. There is never a dull moment in downtown Lee!

**Lodging**: Widely Available Lodging is widely available in the town of Lee, beginning with 3 motels located on Housatonic St as hikers come into the town of Lee from the trail. There is also a motel in Becket directly south of the trail on Rt. 20 as hikers approach the road.

<u>Camping:</u> Limited Availability Camping is available to thru-hikers at the Upper Goose Pond Cabin that is located on the side trail in Upper Goose Pond in Lee, MA.

**<u>Outfitter:</u>** Available Carr Hardware in downtown Lee provides camping gear for hikers. Arcadian Shop Outfitter in the neighboring town of Lenox, MA provides gear and clothing for hikers.

**<u>8 ATM Locations</u>**: Widely Available Greylock Federal Credit Union, Lee Bank, Berkshire Bank, Mobil Gas Station, Big Y Grocery Store, Chase, Shell Gas Station, and Citgo Gas Station.

**<u>Restaurants</u>**: Widely Available There are 15 plus restaurants in the town of Lee, as well as quick dine-in or take-out services at Dunkin Donuts, Starbucks, McDonalds, Subway and the Red Apple Chinese Restaurant.

Laundry: Available Laundry services are available at most motels as well as Lee Wash & Dry Laundromat in downtown Lee.

<u>Grocery Store:</u> Available Big Y World Class Market is available to thru-hikers on Rt. 102 in Lee as hikers approach the town and the Big Y is located conveniently near motels. There are also 5 convenience stores in Lee, 3 of which are located near the motels.

**Farmer's Market**: Available Farmer's Market is located in the town park every Saturday from 10am-2pm, Memorial Day Weekend thru Columbus Day Weekend.

Shuttle from AT to Town: Available Town residents frequently offer rides to thru-hikers when they see them walking to and from the trail. Several trail angels have registered their availability to provide rides to thru-hikers on hiker web sites, and at the local hardware store and Lee motels. Gidget and Gadget's AT Shuttle Service in also available to thru-hikers throughout Berkshire County. Uber services are also available to thru-hikers. Start- up shuttle services are developing in the towns surrounding the AT.

**Shuttle Services available to points north and south along the AT**: **Available** Berkshire Regional Transit Authority, "BRTA", provides local bus service throughout South, Central and North Berkshire County and bus stops on the main roads of downtown Lee. Amtrak Train services are available from the train station in Pittsfield, MA. Peter Pan Bus and Greyhound Bus Services provide long distance bus services from downtown Lee, MA.

Showers: Available Lodging required for showers. The town barber shop and hair dressers provide walk in services.

**Pharmacy/Medical Services:** Available There are 2 pharmacies in Lee, MA: Big Y Pharmacy and Walgreens Pharmacy. Berkshire Medical Center is located 12 miles north in Pittsfield, as well as Urgent Care services in Pittsfield. Fairview Hospital is located 12 miles south in Great Barrington, MA.

<u>Library/Computer/Internet</u>: Available Lee Library provides computers for use. Starbucks and BIG Y provide WIFI and electrical outlets for recharging electronic devices as do chain restaurants in town.

<u>Visitor or Welcome Center</u>: Available The Lee Chamber of Commerce has an information booth located in the Town Park that is a resource of information for visitors to Lee and the Berkshires. It is attended by volunteers from Memorial Day Weekend through Columbus Day Weekend.

**Post Office:** Available Lee Post office is located in the center of town and is easily accessible to thru-hikers with hours of operation Monday through Saturday.

**Public Restrooms:** Available Public restrooms are available in the Lee Town Hall, and the Lee Library. Portable public rest rooms are located across from the Lee Post Office and at the Lee Athletic Field.

**Discounts for Hikers:** Lee Businesses are being approached to suggest that they offer discounts to thru-hikers. **Big Y Supermarket** provides a "**Big Y Loyalty Program Discount Card**" to thru-hikers that inquire at the Customer Service Desk.

Storage for Hikers: Storage is not available at this time.

<u>Shuttle Service to the Airport</u>: Available Thru-hikers can arrange for transportation services posted on hiker internet apps to transport them to Bradley International Airport in Hartford, Connecticut. Uber services and small taxi companies in the area are also available for transportation to the airport.

<u>Car Rental/Taxi Services</u>: Available Uber services are available in Berkshire County. Private and professional car shuttle services are available to hikers on hiker Apps. Car Rental is available from RW's of Lee, MA. Car rental is in available through Enterprise Rent-A-Car and Hertz Rental Services in Pittsfield, MA.

AT Souvenirs: Lee gift shops have expressed interest in providing AT souvenirs for their customers to purchase.

<u>Signage about the AT</u>: To be developed by the town of Lee with the assistance of the Appalachian Mountain Club and the Appalachian Trail Conservancy.

<u>Kiosks about the AT</u>: Kiosks for the Appalachian Trail are located at the both the AT Trailhead at the Jacobs Ladder Scenic Byway Parking Lot located on Rt. 20, Becket, MA, and at the AT Trailhead on Main Road in Tyringham, MA.

# 14) Please describe the locations AND state of the access points of the A.T. Where are the closest trailheads and what improvements might be needed?

Lee town center is within close proximity to AT Kiosks and many town roads that the Appalachian Trail crosses in Lee and the bordering towns of Tyringham, Becket and Washington, MA. The access points are well maintained.

- Trailhead- Jacob's Ladder Scenic Byway and Appalachian Trail Trailhead Kiosk, Route 20 Becket, MA, is 4.7 miles from downtown Lee, MA
   There is ample parking, and the Appalachian Trail, both north and south bound is less than 5 minutes walking distance from the parking lot. Upper Goose Pond Cabin is approximately 1.6 miles southbound on the Appalachian Trail from the parking lot.
- Goose Pond Road, Lee, MA. Appalachian Trail parking in available off road. Access to trail both north and south bound is directly next to parking area, Upper Goose Pond Cabin is approximately 2.8 miles north bound from Goose Pond Road and the Main Rd in Tyringham is 4.3 miles south bound on the trail from Goose Pond Road.
- Webster Rd, Tyringham, MA Appalachian Trail access is 6.4 miles from the town of Lee. There is a limit of 1-2 cars off road parking. Appalachian Trail both north and south bound crosses road next to parking. Upper goose Pond Cabin is 3.4 miles northbound from Webster Road.
- Jerusalem Rd, Tyringham, MA is 5.5 miles from the town of Lee. Limited roadside parking is available for pick up and drops off. Appalachian Trail both north and south bound is directly next to parking. Shaker campsite is approximately 1.9 miles southbound on the Appalachian Trail from Jerusalem Road.
- Trailhead Appalachian Trail Kiosk, 176 Main Rd, Tyringham, MA is 6 miles from downtown Lee. There is limited parking. Appalachian Trail both north and south bound is directly next to parking lot. Upper Goose Pond Cabin is approximately 7 miles north bound and the Shaker campsite is 2.9 miles south bound on the Appalachian Trail from Main Road parking.
- Becket Road, Becket, MA Appalachian Trail access is 5 miles from the town of Lee. There is very limited roadside parking suitable for pick up and drop off. Appalachian Trail both north and south bound is directly next to the roadside parking area. October Mountain shelter is 6.5 miles on the Appalachian Trail north bound from Becket Road.
- County Road, Becket, MA Appalachian Trail access is 10 miles from Lee, MA. There is a limit of 1-3 cars off road parking. The Appalachian Trail both north and south bound is within short walking distance from parking. October Mountain shelter is approximately 1.6 miles north bound on the trail from County Road.
- West Branch Road, Washington, MA, Appalachian Trail Access is 15 miles from Lee, MA. There is a limit of 1-3 cars off road parking. Appalachian Trail both north and south bound is directly next to parking. October Mountain Shelter is approximately 1/2 mile southbound on the Appalachian Trail from West Branch Road.
