I. I, the undersigned applicant, hereby request the Conservation Commission of the Town of Lee to make a determination as to whether:

- 6. The activity will be conducted in connection with the construction or maintenance of electric distribution facilities required to serve a structure or building where construction has been approved under the provisions of this Act.

If the Conservation Commission determines that all or part of the geographic area does lie within a mapped mountain region and that the proposed activity is not exempt from regulation, then I request the Commission determine whether the proposed activity will have a substantial impact on the watershed resources or natural scenic qualities of the mountain region within which it will be performed. (i.e., whether the activity is a regulated activity).
