Ralph Rotondo/Form A

Patrick M. McColgan, Taconic Land Consultants represented Ralph Rotondo in a request for approval of a Form A for property on Bradley Street. The property is located at 362 Bradley Street located on the east side of Bradley Street north of its intersection with Sturgis Avenue. The new parcels created are lot 1 which consists of 20,013 sq.ft. and lot 2 consists of 9,862 sq.ft. and is not a separate building lot.

Tom made a motion to endorse the Form A for Ralph Rotondo as presented. This motion was seconded by Shaun and was unanimously approved, 5-0.

Rodney Clark

Rodney Clark came to this meeting for a discussion regarding a proposed business to be located at 189 Water Street. The property is located in the CBC zoning district. Mr. Clark stated that his proposal is to lease a commercial kitchen at the location for Short term usage by the hour or the day.

The Board agreed the use may be allowed by special permit under for profit designation..

Town of Lee/Revised Site Plan

Broadway Electric submitted a revised site plan for the project located a 385 Pleasant Street for the installation of a solar energy system at the Wastewater Treatment Plant. The new site plan depicted the solar array being shifted slightly to the east so the array does not obstruct an existing driveway. The proposed amendment did not increase the amount of panels.

Sherman made a motion that the revised site plan is not significant and therefore because there is no substantial change it does not require an amendment to the special permit. This motion was seconded by Buck and was unanimously approved, 5-0.

F.L. Roberts/Sign Permits
