Article 2. Veterans' Services Fiscal Year 2013 Operating Budget Increase

To see if the Town will vote to amend Article 2 of the Annual Town Meeting held on May 10, 2012 as amended by Articles 1 and 3 of the October 4, 2012 Special Town Meeting by appropriating an additional \$10,000 to increase the Veterans' Services Account (543) from \$33,447 to \$43,447, such additional amount to be transferred from available funds, or to take any other action relative thereto. **Capital Outlay and Finance Committee recommend approval.**

Article 3. Sewer Department Fiscal Year 2013 Enterprise Fund Transfer Increase

To see if the Town will vote to amend Article 8 of the Annual Town Meeting held on May 10, 2012 as amended by Article 2 of the October 4, 2012 Special Town Meeting by transferring from the Sewer Enterprise Account the sum of \$113,709 to increase the funds transferred from \$219,211 to \$332,920 to meet the Sewer Department's \$2,138,983 appropriation (Accountants 440,442 & 443), or to take any other action relative thereto. Capital Outlay and Finance Committee recommend approval.

Article 4. Tyringham Road Water Main Replacement Design Services

To see if the Town will vote to transfer from the Water Enterprise Account the sum of \$20,500 to the Reserve Fund Account (132) from which \$20,500 was transferred to the Water Department Account (452) to expedite the design of the Tyringham Road Water Main Replacement Project. Capital Outlay and Finance Committee recommend approval.

Article 5. Prior Fiscal Year (2012) Pre-employment Medical Examination Invoice (9/10 Vote)

To see if the Town will vote to raise and appropriate \$255.00, or any other amount, to pay a June 29, 2012 invoice from Occupational Medicine Services which we received after the fiscal year closed, such amount to be transferred from available funds, or to take any other action relative thereto. This invoice appeared after the Finance Committee's last met.

Article 6. Transfer of Proceeds from the Sale of Cemetery Lots to the Perpetual Care Account

To see if the Town will vote to authorize the transfer of the sum of \$1,400, or any other amount, from the Sale of Cemetery Lots receipts to the Fairmont Perpetual Care Trust Account, or to take any other action relative thereto.
