Dear Tim,

On behalf of HRI, you filed a Motion on December 12, 2022, to increase by 60 days the closing of the record of the Adjudicatory Hearing scheduled to expire on December 19, 2022. As reasons for this request HRI stated: *HRI has additional relevant expert testimony that it wishes to submit into the record in this matter. This proposed expert testimony will be submitted in the form of affidavit(s) and is material information that directly relates to the issues before the LBOH in this matter. However, because of the other commitments by said experts involved and the upcoming holidays, HRI states that it needs an additional 60 days, until February 18, 2023, to submit important written expert testimony into the record in this matter for LBOH's consideration. (Motion of HRI)* 

The LBOH received email correspondence from EPA which has decided not to oppose the Motion with a caveat as follows: *EPA takes no position regarding HRI's motion for an extension of the Board's hearing deadline. If additional testimony is submitted, however, EPA requests a reasonable opportunity to review that testimony and respond, if appropriate. If the Board decides not to extend the hearing deadline to February 18, 2023, EPA requests time to submit additional information to the Board and adequate advance notice of the date of the close of the hearing. (EPA's Response and Request for time.)* 

As of today, December 20, 2022, the LBOH has not received any correspondence in response to HRI's Motion.

Therefore, based on your petition request, the LBOH grants HRI's and EPA's Requests and issues the following filing time order:

HRI's Motion for an extension of time to file further additional expert testimony is granted. HRI must file on or before February 18, 2023, a single document with a table of contents and curriculums vitae of all additional experts if any. The curriculum vitaes of experts DeSimone and

Carpenter are already part of the record. EPA's additional request for time to respond is also granted. EPA must file its response in a single document with a table of Contents by March 19, 2023.
