

COMMUNITY MASK & AT-HOME TEST KIT DISTRIBUTION

In collaboration with the New England Rural Health Association for Rural Vaccine Equity and the Rural Health Network of Fairview Hospital, the public health nurses continued to distribute KN95 masks and pamphlets to locations that serve populations at increased risk for severe COVID-19 illness and/or those who may face barriers to the purchase of high efficiency face masks. Additional masks from the Massachusetts Emergency Management Association were secured and continue to be distributed by the PHNs to the sites below on an as-needed basis.

COVID-19 DATA DASHBOARD AND UPDATES

This summary of local COVID-19 numbers and transmission trends, along with prevention guidance and updates about vaccine and testing availability, has continued to be provided on a weekly basis. The dashboard and update are distributed to a wide audience that includes local leaders, businesses, school administrators, press, etc. They are also posted on the Tri-Town Health Dept. website and on the SBPHC Facebook page. The content is featured in its entirety each week in the Berkshire Edge and is regularly quoted in Berkshire Eagle articles. It is often shared in community newsletters or listservs (Alford, Sheffield, Monterey) as well.

DISEASE/INJURY PREVENTION PROJECTS

- **Establishment of a Vaccine Administration Site:** SBPHC has completed the process of becoming registered as a vaccine administration site, able to receive state-supplied flu vaccine for eligible children, and able to be reimbursed by both private and public insurers.
- **Homebound Vaccines:** SBPHC PHNs are still in the process of identifying homebound residents for a homebound vaccine program, which will start with flu vaccine in Fall 2022. We are planning outreach to local primary care practices later this summer and will advertise in the Shopper's Guide, local community newsletters, etc.
- Rapid COVID-19 Testing by Appointment: Individuals who need a rapid antigen test can still get one by
 appointment in Lee, Sheffield or Great Barrington by reaching out to jill@tritownhealth.org or (413)717-7209. This
 program has been offered since April. So far there have been 2 participants, both from Sheffield, in May.
- Car Seat Clinics: Car seat installation and safety checks are available, as are free replacement car seats received from grants. A marketing flyer has been shared on social media and will be distributed to local pediatrician offices. Individuals who need a car seat checked can make an appointment by reaching out to iill@tritownhealth.org or (413)717-7209. So far 5 car seats have been distributed to 2 families, 1 from Pittsfield and 1 from Becket, in June.

UPCOMING PROJECTS

- MA DPH Internship Program: We applied for and received a summer intern, who started in mid-May and will continue through early August. She has been exploring de-identified MAVEN data, with the overall goal of describing epidemiological characteristics and possibly identifying relationships between demographic characteristics for tick-borne and other illnesses. She is also using graphic design skills to help design flu clinic flyers, assist with a project for the Opioid Task Force, and is reviewing local health department websites in order to provide recommendations for a future SBPHC website.
- Fall 2022 flu clinics: A total of 1,900 flu vaccine doses have been ordered from private supply (400 high-dose for seniors) for Fall 2022 community clinics in Collaborative towns. We will use a combination of state-supplied and private vaccine for the school clinics. We are also keeping an eye on COVID-19 booster developments and may possibly administer those as well, if there is a need. Clinic planning is ongoing and will include outreach to local school nurses, COA and community center leaders later this summer.

SOUTH COUNTY OPIOID WORKING GROUP (SCOWG) PROJECTS

SBPHC facilitates the SCOWG, which is a group comprised of a wide variety of organizations working a variety of goals around substance use disorder (SUD) in Southern Berkshire County, including:

- Facilitated monthly SCOWG Meetings;
- Organized Drug Take Back efforts, including Drug Take Back Day on April 20th, 2022 and development of additional mail-in and at-home disposal options for narcotics;
- Provided outreach to medical providers to promote Rural Recovery's referral tree- a digital program to identify SUD providers and connection with a recovery coach; and
- Developed open letter supporting harm reduction interventions to educate the public.

COMMUNITY COLLABORATION AND ENGAGEMENT

As members of the South County community, we engage with other meetings to provide a public health nursing perspective and also be able to tie into and enhance other efforts going on in our community. Meetings attended include:

SBPHC POLICY UPDATES

- The SBPHC created a subcommittee to engage stakeholders to identity opportunities to pool opioid settlement funds in a way to maximize efforts to ensure these settlement funds are invested back into the community for those affected with substance use disorder. A South County meeting was held to engage South County town managers to explore ideas. While no decisions were made, we are actively communicating to see if there is a path forward to pool resources.
- The SBPHC clinical staff have been actively engaging with recreational summer camps to ensure they are supported and have access to the right information to include a review of their policies and procedures.
- The 10 town Intermunicipal Agreement is completed and submitted to all town clerks and the DPH.
- The FY22 approved SBPHC workplan was in full compliance and now awaiting instructions for a FY23 workplan to be developed.
